United Water Softeners (United Waterworks LLC) Guardian Package water softener valve, parts, brine tank, media tank, and resin, are warranted by United Waterworks LLC, to be free from defects in materials and workmanship under normal use within the service and operating parameters listed below for a period of 5 years from the date of purchase. United Waterworks LLC will provide labor under said warranty at no charge for 1 year from the date of purchase. This limited product and material warranty may transfer from the original purchaser to another person or entity provided a service call inspection and a \$289.00 transfer fee is performed by United Waterworks LLC and paid by the new owner/entity. This limited warranty may transfer from the original location provided the warrantied equipment is removed and reinstalled by United Water Softeners and these services are paid for at the current market rate by the customer. The United Waterworks LLC Sentinel water softener should be inspected and serviced with the UnitedCare GUARDIAN PLUS maintenance plan on an annual basis. United Waterworks, LLC under this limited warranty shall be limited, at its option, to replace or repair any system(s) covered by this Limited Warranty. No warranty is made with respect to defects not reported to United Waterworks, LLC within the warranty period and/or defects or damages due to neglect, misuse, alterations, accident, misapplication, physical damage, or damage caused by fire, acts of God, freezing or hot water or similar causes. For outdoor installations where the system(s) are not undercover, a weather cover must be utilized for the warranty to be valid.
